

Special Announcement Children's Scholarship Program 2019

Dear Plan Participant:

We are again very pleased to announce a special **Children's Scholarship Program** that will be donated by our Long Term Disability Plan Administrators, California Public Safety Administrators, Inc.

Four scholarships will be given in two categories, 3 in Category One, and 1 in Category Two.

CATEGORY ONE

Applicants must be **high school seniors** who are enrolled or planning to enroll in a full-time course of study at an accredited two or four year college, university, or vocational-technical school. Applicants must also have a 3.0 grade point average on a 4.0 scale. (Three scholarships will be awarded.)

CATEGORY TWO

Applicants must be **sophomores or juniors in college** enrolled in a full-time course of study at an accredited college, university or vocational-technical school. Applicants must have maintained a 3.0 grade point average during the first two years of college on a 4.0 scale. (One scholarship will be awarded.) Previous recipients are not eligible and need not apply.

Applicants must be the child of a CLEA Plan Participant who has been a Plan Participant for a minimum of one year prior to April 1, 2019 or a retired CLEA Plan Participant who is currently a Participant in the NPFBA Long Term Care program.

Scholarship distribution will consist of \$2,000 - four awards of \$500 each.

The application may be downloaded by going to California Law Enforcement Association's website CLEA.org or a hard copy may be requested by calling California Public Safety Administrators, Inc., toll-free at (800) 832-7333. The application must be completed and **postmarked by April 1, 2019**.

You are responsible for seeing that all supporting documents are submitted. Our committee reserves the right to process only those applications found to be complete as of the application postmark deadline of April 1, 2019. Applications are forwarded directly to the committee. California Public Safety Administrators, Inc. does not have access to the applications until after the review process.

Scholarships are awarded mid to late May. Recipients will be notified by mail and a list will be published on our website.

To be eligible to apply for these scholarships, you must:

- Be a child or step-child of a California Law Enforcement Association (CLEA) Plan Participant who has a minimum of one-year Plan participation with the association as of the application deadline, or a retired CLEA Plan Participant who is currently a Participant in the NPFBA Long Term Care program.
 - Step-children Please include a birth certificate and marriage certificate of parent to Plan Participant.
- Be a high school senior who is planning to enroll or a college sophomore or junior who is enrolled
 or planning to enroll in a full-time course of study at an accredited two- or four- year college, university,
 or vocational-technical school.
- Have a minimum of 3.0 grade point average on a 4.0 scale.

Remember, this application becomes valid only when the following have been submitted:

- Completed Student Application
- Transcript of Grades
- Step-children (birth certificate and marriage certificate of parent to Plan Participant).
- Postmarked on or before April 1, 2019
